1. Artists may submit work in one of two ways

  - Hand-delivered to AVA
2. Pre-registration and pre-payment fee is required to participate
3. Submission of work does not guarantee that either piece will be selected for the exhibition
4. Entries submitted outside of the associated time will not be considered

- Artworks will not be outright accepted through Slideroom. Works will either be not-accepted or moved on for final jurying.
- Works moved on for final jurying must be delivered to AVA: Saturday, June 17; Monday, June 19; or Tuesday, June 20, 2017 between 11:00am – 5:00pm.
- Hand-delivered submission fee is waived for works moved-on through this process.

##### ENTRY FEES:

- One entry: \$30 member/\$35 non-member
- Two entries: \$35 member/\$40 non-member
- **Works must be brought to AVA: Saturday, June 17; Monday, June 19; or Tuesday, June 20, 2017 between 11:00am – 5:00pm**
- Number of artworks, title, media, price and size for each piece must be emailed to AVA's Exhibition Manager, Margaret Jacobs at [Margaret@avagallery.org](mailto:Margaret@avagallery.org) prior to artwork delivery. Please use AVA's 2017 Juried Summer Exhibition in the headline.

## ENTRY SPECIFICS

---

- **Eligibility: All artists residing in New Hampshire or Vermont**
- Up to two recent works (made during the past three years) that were not shown previously in one of AVA's Juried Exhibitions. Submissions must be delivered together.
- All works must come gallery-ready for exhibition, dry and finished.
- Two-dimensional works are not to exceed 60 inches in any direction.
- Sculpture entries are not to exceed 200 lbs.
- All works must be for sale. (AVA retains 40% commission on sales.)

## THREE JUROR'S AWARDS & THE CORNELIA M. RAHMELOW PHOTOGRAPHY PRIZE

- Awards will each be accompanied by \$250 and award winners will be featured in an exhibition at AVA in summer 2018.
